The Meadows of Micah Creek, agent for the above-named Stallion, will herein be referred to as Stallion Owner/Agent. This service and contract is subject to the following:

- 1. The stallion breeding fee plus all unpaid expenses including but not limited to mare care, veterinary care, etc. will be payable ten days from date of invoice. Booking fee, collection and shipping fee(s) and/or expenses related to breeding of contracted mare shall be paid prior to shipment of any semen. The booking fee is non-refundable and will be deducted from any breeding fee prior to any refunds. 18% APR will be charged on all accounts unpaid after 31 days. On-site Mare will not be released to owner until all expenses are paid in full. Board will be payable through date of pickup.
- 2. A copy of the registration papers (all applicable associations front and back) and valid EIA (Coggins) test shall accompany the Mare. If these are not presented upon the Mare's arrival, the Stallion Owner/Agent shall have the right to refuse any mare or mares until such documentation can be provided or have a licensed veterinarian complete EIA requirements at the expense of the Mare Owner, this includes any and all charges for farm call and testing. It is recommended that mares are wormed within 30 days prior to being bred and that a copy of information regarding the mare's medical health be provided.
- 3. The Mare Owner shall agree that each mare offered for breeding shall be in sound breeding condition and free from infection or disease. The Mare Owner will provide the breeding farm with a written breeding history, if requested. Any mare certified by the Stallion Owner/Agent and/or Attending Veterinarian not to be, in their opinion, in sound breeding condition shall not be bred until she meets that requirement.
- 4. The Stallion Owner/Agent agrees to diligently try to settle the Mare and will breed by requested method. However, should the mare not settle within a reasonable amount of time, generally 45 days, the Stallion Owner/Agent shall have sole discretion in determining the best method of breeding the mare to achieve pregnancy. This includes but is not limited to ultrasounds, veterinary assistance, medication and any other means necessary to settle the mare and maintain pregnancy. The Mare Owner is responsible for all cost associated with breeding difficulties, including but not limited to care and any medications deemed necessary by the Stallion Owner/Agent and/or attending veterinarian. Failure to maintain medications for pregnancy and follow instructions from Stallion Owner/Agent/ and or Attending Veterinarian will void all warranties.
- 5. Live Foal Guarantee A live foal is defined as a foal that stands and nurses for a minimum of 24-hours. A return breeding for all nonviable foals or pregnancies lost after being confirmed by ultrasound, shall be completed in the current season or the 2024 season at no additional breeding or booking fee. All other charges, including but not limited to collection and shipping fees, mare care, veterinary care, etc. are payable for each visit. Rebreeding beyond the 2024 season shall be subject to the discretion of the Stallion Owner/Agent and may be subject to an additional fee(s) and new contract. It is understood that if the mare proves barren or becomes unbreedable during the term of this contract, the Mare Owner shall have the option to designate one substitute mare for breeding or to request a refund of stallion breeding fee. Booking fee and all other unpaid expenses incurred will be deducted from the breeding fee prior to refund. Breeding for substitute mare is subject to

the terms and conditions of the original agreement for breeding and an addendum will be added to this contract and shall be guaranteed for the 2024 season only and will not be continued past that date unless by written agreement. No refund will be honored or may be requested once a substitute mare has been requested/designated. Proper notification by certified mail of the loss of foal/pregnancy is required and is defined as written notification within seven days of the loss of the foal/pregnancy. Mares not ultrasounded within the thirty days of cover/insemination shall be charged an additional booking fee for each return visit for breeding or shipped semen.

Additional Guarantees are as follows:

states that each mare bred shall produce a "live" colored foal which meets the registration requirements for their respective registries. Rebreeds will be granted for the following year to any mare that produces a foal not testing positive for "white" generates
(Leopard - LP for ApHC) (Lethal White Overo - OLWS, Splash White - SW, Dominant White - DW, Sabino 1 - Sab1, Tobiano -
Tob for APHA) and/or not meeting required color requirements for their respective breed. All Solid or Non Characteristic foal
must be registered prior to rebreed. Nominations vary year to year and are not guaranteed Initials
□ Stallion Service Auction Guarantee: This guarantee applies to any breeding that is paid for through a donated Stallion
Breeding Auction. No Booking fees shall be required for donated breedings for initial year. This guarantee will include live foa
that stands and nurses within the first 24 hours only. No other guarantees apply to Stallion Service Auction Donated breedings
This contract shall include the terms set for and by each auction regarding rebreeding or refund as well as the terms lister
herein. Stallion Owner/Agent will be held harmless for any refund of any breeding fee paid to any entity from which a donated
breeding has been purchased. Service costs are not included in any Stallion Breeding Donation unless specified and listed in
this contract. These costs include but are not limited to breeding costs, mare care, veterinary care, farrier care, or any other
care not covered by Stallion Breeding Fee and will be charged separately. These costs are due and payable and non-refundable
regardless of the determination of refund from the entity which the breeding was purchased through. Should the stallion die of
become unfit for service, the entity shall have the option of including a breeding to any other stallion owned by the Stallion
Owner/Agent to substitute with the consent of the Stallion Owner/Agent.

□ Live Color Foal Guarantee: This guarantee applies to APHA Regular Registry and ApHC Colored mares. This guarantee

- 6. The breeding season shall begin February 1st and shall end June 30th of the year covered by this contract. No mares will be accepted prior to February 1. Special arrangements must be made for mares being bred after June 30th and be in writing and agreed upon by all parties in advance.
- 7. Genetic Testing Requirements: Recommended five panel plus IMM for all mares.
- 8. It is further agreed that should the above-named stallion die, or become unfit for service, then this contract shall become null and void, and any money paid as a stallion breeding fee, minus booking fee, shall be refunded to the Mare Owner unless Mare Owner requests substitution for another stallion owned by Stallion Owner/Agent. The use of any frozen semen for contracted breeding shall be at the discretion of the Stallion Owner/Agent.
- 9. A breeder's certificate will be released to Mare Owner after all expenses have been paid in full. For associations that allow online release, all breeding certificates will be released online and will not be mailed unless written request is made by Mare Owner. It is the responsibility of the Mare Owner to supply the Stallion Owner/Agent with any and all documents required for registration of a foal outside of the AQHA/APHA/ApHC, in a timely fashion. All documentation must be **received no later than October 31 of the breeding year**. This includes but is not limited to any and all forms to file Stallion Breeding Report or Registration. Any documentation received later than October 31 will be charged an administrative fee (which will include any late fees accrued for the breeding reports) and must be paid in full before completion and submission of paperwork to respective associations.
- 10. Waiver of Liability. It is understood that Stallion Owner/Agent, their employees, veterinarians, and guests shall not be liable for accident, sickness or death of a mare or mare and foal, whether from natural or unexpected causes, this includes but is not limited to
